LifeWays Childcare Provider Training – 2010-2011

LifeWays Tuition: \$4,280. The fees are described below.

How to apply:

Complete a **Program Application**, and if applicable a **RSC Loan/Scholarship Application**. Completed Applications are due by September 10, 2010. There is a minimum enrollment required for this program, so please apply today!

1. Download applications from our website www.steinercollege.edu >Admissions >Forms; OR
2. Call 916-961-8727 x 100 for an application packet to be mailed to you.

Enrollment and Payment Options†: (We accept cash, check or MasterCard/Visa)

1. Enroll in the Complete Program. Payment options:

- a. Pay for the program in full 10 days before the beginning of class.
- b. Apply for a four consecutive month payment plan beginning Sept. 22nd = \$1220 (includes a \$50 set-up fee); Oct. 22, Nov. 22, Dec. 22 = \$1070 each. *This requires: credit or debit card that will be charged monthly.*
- c. Scholarships – Depending on the availability of funding a few 10-20% scholarships may be available. Students must prove financial hardship. *This requires: completed RSC Loan/Scholarship Application; \$15 credit check fee.*
- d. Apply for RSC “tuition only” Loan = \$2800. Interest is 9%; payments approx. \$255/month for 12 months). The remaining tuition and fees (approx. \$1700) are paid 10 business days before the first class. *This requires: completed RSC Loan/Scholarship Application; \$15 credit check fee; a \$135 loan fee; credit or debit card that will be charged monthly.*
- e. Apply to your local One-Stop Center for federal Workforce Investment Act Funds. To locate one near you, go to www.careeronestop.org. These training funds are available to all eligible adults and we highly recommend you look into this option. This process requires several steps and takes at least 4-6 weeks before you will know if you qualify for funding. The Lifeways Program is listed on the California Employment Provider Training List (EPTL). Out of state applicants, please contact Admissions immediately if you are thinking of this option, as RSC would need to apply to be included on your State Employment Development Office’s Provider List and this will take extra time.

2. Enroll in the program on a per session basis: (please let Cynthia Aldinger know if you choose this plan).

On the Program Application:

Indicate you are paying per session (requires a credit card). We will deduct the tuition amounts listed below 10 days prior to each session.

The charges per session are due 10 days prior to first class of each session†:

Fall 2010: \$1075 + \$50 application fee * + \$50 registration fee** = \$1175 due September 20, 2010
 Spring 2011: \$1075 + \$50 registration fee** = \$1025 due February 14, 2010
 Summer 2011: \$2150 + \$50 registration fee** = \$2200 due 10 business days prior to 1st class – date TBA

Non-refundable Fees:

- ***Application fee:** There is a one-time application fee of \$50 (\$70 if turned in after 30 days prior to the program).
- ****Registration fee:** \$100 if tuition is paid in full; \$50 if paid per session.

† **Note:** payment amounts listed on this document are a close approximation to actual amounts – additional fees, such as CA Tuition recovery Fund, may be added at the time your contracts are created.
